



Round Top-Carmine ISD  
Transfer Agreement  
2018-2019



This Transfer Agreement establishes the terms and conditions for a student to attend the RT-C ISD public schools as a transfer student for the 2018-2019 school year. When requesting that a student be permitted to attend RT-C ISD schools, agreement with the following is required:

1. This transfer is effective for the current school year only. District approval of this transfer creates no right or expectation that the student will be admitted as a transfer for any subsequent school year.
2. This transfer is approved for the named student only. District approval of this transfer creates no right or expectation that another student from the same family will be admitted as a transfer.
3. The student must maintain the acceptable 90% level of attendance, and compliance with RT-C ISD rules and regulations, including the Student Code of Conduct throughout the entire year.
4. The parent or student will be responsible for transportation to and from the RT-C ISD campus to which the student is assigned.
5. The student and parent acknowledge that eligibility of transfer students for participation in any UIL activity or other activities governed by the UIL rules and regulations will be determined in accordance with UIL rules and regulations.
6. Except as modified by this transfer agreement, the student will be subject to all policies, regulations, rights, privileges, and responsibilities of enrollment in RT-C ISD as if he or she resided in the district.
7. Students who have been expelled from other districts will not be enrolled until the matter has been resolved with the home district, and the transfer has the consent and approval of the Round Top-Carmine building Principal, Superintendent, and the Board of Trustees. Discipline records of applicants will be reviewed and considered prior to acceptance.
8. Listed below are some of the factors may cause admission to be denied or revoked for a student applying for an inter-district transfer.
  - Failure to comply with the “Standards of Conduct” as per the RT-C ISD Code of Conduct
  - Any suspensions from school
  - Any placement to an alternative education placement center
  - Any expulsions from school
  - Any matter involving delinquent conduct of a student where he/she is placed on probation, placed under the supervision of a court or probation officer, or any other conditional release from the court

- Any felony/criminal conviction
- Excessive tardiness
- Below grade level performance on the most recent state-required assessment
- Unsatisfactory performance for academic courses from the previous school year
- See FDA Local (enclosed), for exemptions for students with special education services and academic requirements

9. A transfer shall not be approved that would limit the educational opportunities or the health and well-being of resident students.

10. The Round Top-Carmine Board of Trustees has the authority to accept or reject any transfer request, provided that such action is without regard to race, ethnicity, religion, sex, disability, or national origin.
